TO QUALIFY, BUYER BROKER/AGENT MUST:

Register prospective buyers for specific properties, <u>prior to any inspection of the property by the buyer and no less than 48 hrs prior to the auction</u>. Broker must complete the "<u>Broker Participation Acknowledgement Form"</u>, sign the <u>Buyer Broker Participation Terms</u> and submit it to us via fax at (866) 657-2501 or email at <u>bijenningsauction@jenningsauction.com</u>

- Submit Broker Participation Acknowledgement Form and Buyer Broker Participation Terms no less than 48 hours prior to the auction and prior to any showing.
- ❖ Accompany and sign in with your client at any inspection of the property.
- ❖ Broker Participation Acknowledgement Form must be signed by both the prospective buyer and the broker.
- ❖ Attend the auction with the prospect.

*No broker/agent will be recognized on a prospect who has previously contacted Jennings and Grosh, Inc. No commission will be paid to any broker acting as a principal in the purchase of the property. Broker/agent certifies that neither broker/agent, his/her employees, agents, nor any member(s) of his/her immediate family, or his/her employees or agents immediate family, is or will be the buyer.
